PROCUREMENT OF ANDROID TABLETS

The Government of Sindh (herein after called Borrower) has received financing from the International Development Association (IDA) (the Bank) in the form of a credit (hereinafter called credit) towards the cost of the Integrated Health and Population Project (SIHPP) in the Sindh Province. The Program Director, Project Management Unit, Sindh Human Capital Investment: 1000 days, **Sindh Integrated Health and Population Project (SIHPP)** Health and Population Department, Government of Sindh an implementation Agency intends to apply part of the proceeds of this credit towards payments under the contract for which this invitation of quotation is issued as per World Bank Procurement Regulations for IPF Borrowers (September 2025) available on www.worldbank.org.

Project Management Unit Sindh Human Capital Investment: 1000 days, Sindh Integrated Health and Population Project (SIHPP) shall be the Purchaser and required quotations from bidders / suppliers who are registered with the relevant Government Tax Authorities and possess the required experience and capacity.

Interested bidders / suppliers may submit their sealed bids/quotations on or before 14:00 PST, 9th July 2026, at the below-mentioned address.

Preparation of Quotations:

You are requested to quote for the items given in Annex-A, by submitting a signed & sealed quotation on the company's letterhead.

This procurement process will be conducted in accordance with the World Bank Procurement Regulations 2020 for IPF Borrowers (Revised in September 2025). The acceptable terms and conditions of the lowest, responsive quotation shall be incorporated in the Purchase Order / Notification of Award of Contract.



Terms and Conditions:

1. The Supplier / Bidder shall be eligible to participate in accordance with the World Bank Procurement Regulations for IPF Borrowers and shall not be under suspension, debarment, or ineligibility under World Bank sanctions or any applicable Government authority.
2. The Supplier / Bidder shall be a legally registered entity having National Tax Certificate (NTN), valid GST Registration Certificate, and the firm must be an active taxpayer.
3. The Supplier / Bidder shall demonstrate relevant/similar experience in the supply of I.T / Electronics Equipment's. Evidence of at least two completed contracts of similar nature worth of Rs. 10 million each.
4. All Quotations must be accompanied by a Bid Security equivalent to two percent (02%) of the quoted price in Pakistani Rupees, in the form of a Pay Order, Bank Draft, or Bank Guarantee issued by a scheduled bank in Pakistan, in favor of the Sindh Integrated Health and Population Program, Health Department, Government of Sindh. Quotations submitted without the required Bid Security shall be rejected.
5. The quotation shall include a completed price schedule along with technical compliance statement/brochure.
6. All goods supplied shall be brand new, unused, and of the latest available model/production. Goods shall fully conform to the technical specifications provided in Annex-A.
7. Prices shall be quoted in Pakistani Rupees and shall be inclusive of all applicable taxes, duties, levies, transportation, insurance, delivery, and any other associated costs required for supply of Android Tablets.
8. All Quotations must be valid for at least 30 days from the closing date of the Quotation.
9. Delivery of items is required within 30 days after signing of contract agreement. Partial deliveries are allowed. Delivery location will be Project Management Unit (PMU), SIHPP, Office No.201, Plot No.180-C, Al Murtaza Commercial Lane 2, Phase-VIII, Karachi
10. The procuring agency will not pay any of the suppliers' costs of preparing their proposals under this quotation.
11. In case of anomalies between unit rates or prices and the total amount quoted, the unit rates or prices shall prevail. In case of discrepancy between words and figures, the former will govern. Bidder / Supplier shall remain bound to accept the arithmetic corrections made by the Procurement Committee.
12. The Prices indicated in the quotation shall be final prices as no negotiations are expected.
13. Delivery shall be completed within thirty (30) days from the date of signing of Contract Agreement. In case of delay in delivery, liquidated damages shall be applied at the rate of 0.5 percent per week or part thereof of the undelivered portion of the Goods. The LD shall not be exceeded more than 10% of the total value.



14. The payment shall be made after successful delivery, inspection, and acceptance of the goods by the Purchaser upon submission of a valid invoice and required supporting documents. Partial payments on successful delivery are allowed. No advance payment shall be made.
15. The Bidder / Supplier shall provide the minimum 1-year manufacturer warranty with local after-sales support
16. Quotations shall be evaluated on the basis of substantial responsiveness to the technical and commercial requirements, and award shall be made to the supplier offering the lowest evaluated responsive quotation.
17. A quotation shall be considered substantially responsive if it meets all mandatory requirements of the RFQ without material deviation or reservation.
18. All the taxes and duties are deducted as per Government Laws.
19. The Purchaser reserves the right to accept or reject any quotation, and to cancel the procurement process at any time prior to contract award, in accordance with applicable World Bank Procurement Regulations.
20. The Supplier shall comply with the World Bank Anti-Corruption Guidelines, including prohibition of fraud, corruption, collusion, coercion, and obstructive practices.
21. Quantities may be increased or decreased.
22. Quotations with required documents must be delivered to the address below on or before 9th July 2026 at 14:00 hours (Pakistan Standard Time) and quotations will be opened after 30 minutes at 14:30 hours. Late receipt of Quotations will be rejected.
